



Thank you Barb and Rehabilitation Specialists for helping me be able to continue with my week without skipping a beat.



I am an occupational therapist who has treated several of Dr. Barbour's patients for various diagnoses at a local hospital.

Approximately 2 years ago, I was suffering from severe mid-lumbar back pain. The pain was intense that I literally had to lie down for 15 minutes in between treating each patient.

I was not real familiar with Dr. Barbour's treatment technique at the time; however, 2-3 people talked to recommended him.

I called, and in spite of being booked up for that month, Dr. Barbour treated me within a few days. I was interested in the treatment techniques & he took the time to explain everything to me. His office staff was also very congenial & helpful.
